 All that certain piece of land containing thirty seven acres, more or
 less, situated, lying and being in the County aforesaid, also containing a small
 portion of city lots, together with and part of the State road in these Townships
 and having the following metes and bounds, to wit: Beginning at a stake in road
 at junction of bridge over Chehaw Branch, thence N. 60° E. 100 rods thence
 N. 70° E. 23.80 to a stone in center of State road, thence along State road N. 62° W. 40'
 to a state 38 acre in crossing of Mill Branch road, thence along said road to
