 with said Holloway's line E. one hundred & fourteen (114) feet to a  
 stake, thence S 9 $\frac{1}{2}$  W. Seventy-five (75) feet to a stake J. H. Seawright's  
 corner; thence with the Seawright's line N. one hundred and two  
 (102) feet to the beginning, containing eighty-one hundredths  
 (81/100) square feet, more or less,
