and States,  
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and  
release unto the said Mattie J. Earle, and her heirs and assigns, all that certain  
piece parcel and lot of land situate, lying and being in said County and  
State in the City of Greenville, on Washington Street, containing one half  
of nine tenths of an acre more or less, and having the following lines and  
bounds courses and distances to wit; Beginning at a point on Washington  
Street at Ida Le Mauldin's corner, and running thence with Mrs. Mauldin's line 18 ft  
6 1/2 c 25 c to John Street, thence with John Street 14 ft 1/2 c 5 1/2 c to a stake, thence  
18 ft 6 1/2 c 25 c to a stake on Washington Street, thence with Washington  
Street 8 1/2 ft 1 c 10 1/2 c to the beginning of corner, being the one half of  
the lot purchased by me from J. Q. Donaldson by deed bearing  
date 29th September, 1874, bounded on the South by Washington  
Street, on the East by Mrs. Ida Le Mauldin, on the North by John
