(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. N. Watkins, the South Western part of all that piece parcel and lot of land in the City of Greenville County and State aforesaid, on the East side of Anderson Street and having the following meets and bounds viz: Beginning at an iron pin 34 on said Street and running thence S 71 1/2 W 33 1/2 feet to an iron pin 34 on Berry Megee's line, thence with said line N 24 1/2 E 122 1/2 feet to a stake 34 to Orr Martin's line corner thence with Martin's line N 71 1/2 W 33 1/2 feet to an iron pin 34 on Anderson Street, thence with said Street S 32 1/2 W 12 1/2 feet to the beginning, and bounded by lots of A. B. Byrd, J. H. Earle, Martin and Megee, and said to contain nine tenths of an acre, more or less,
