in City of Greenville, County of Greenville, State aforesaid, lying on East side of River Street in said City, containing one third of an acre, more or less, having the following meter and bounds: Beginning at a stake on River Street at corner of lot #2 of Messrs Hill property, formerly belonging to Mountain City Land and Improvement Company, now owned by W. J. Craigin, thence along line of lot #2 S 67° 05' E one hundred and fifty four 7/10 (154.7) feet to stake, thence S 47° 15' W fifty nine 5/8 feet to stake at corner of lot #1, now owned by Davis Sumner, thence along line of Davis Sumner N 41° 30' E One Hundred and fifty five 1/2 (155.5) feet to River Street, thence with River Street N 26° 30' E Sixty six 7/10 feet to beginning corner being lot #3 of lands of Mountain City Land and Improvement Company, according to survey of J.
