(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and  
release unto the said Garrison M. Bryant his heirs and assigns forever  
all my right title and interest in and to all that tract  
or plantation of land, lying and being situate in the County  
of Greenville, State of South Carolina, containing Twenty (20)  
acres more or less, bounded by lands of Leopoldo Bryant,  
lands of G H Bridwell, lands of C A Wood, and lands  
this day conveyed by me to J. M. Nesbit, and is part of  
what is known as the "Bubble tract."

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in  
anywise incident or appertaining,  
TO HAVE AND TO HOLD, all and singular the said Premises before mentioned unto the said  
Garrison M. Bryant his Heirs and Assigns forever.

And I do hereby bind myself and my Heirs, Executors and Administrators, to warrant and forever  
defend all and singular the said premises unto the said Garrison M. Bryant his

Heirs and Assigns, against me and my Heirs, and every person whomsoever, lawfully claiming, or to claim the same, or any part thereof.
