(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John J. Willis, all that piece parcel of tract of land situate  
lying & being in the County & State aforesaid, near the town of Greer &c  
in a small branch of South Tiger River, & having the following metes & bounds  
viz: - Beginning at a stone 34 on the road leading from Greer & running  
thence N 6 1/4 E 12.50 to a stone 34, thence N 43 1/4 W 5.00 to a stake 34 in branch, thence  
up the branch as a line to a stake 34 in the beginning of the branch by a road,  
thence eastwardly with said road 7.30 to a stake 34 in fork of road, thence  
with said road 3.38 to the beginning corner.

The same being known as tract No 15 of the lands of Geo Cunningham  
deed & better described by a plat thereof made by J. M. Southern D. B. 6<sup>th</sup>
