Farmer, A certain tract of land lying in Greenville place containing Seventy four acres, more or less, Beginning on a stone corner at corner of Edwards corner, and from thence N 30° 45' W 24 chains 50 links to the center of said Rail Road, Green & Edwards corner, thence with a N 75° West 38.75 chains running the wagon road to Chick Springs on the Jackson Grove Road to a stone, on the side of said road Green & Westfield corner, thence south 21° E with Westfield line 10.75 chains to a stone at corner of Lands field; Also Westfield corner, thence south 72° 45' E 16.88 chains with said line along the said Chick Springs Wagon Road to a stake in the center of said Rail Road, thence with the center of said Rail Road south 53° West 70.45 to a stake in center said Rail Road, thence S 82° 45' East 36.74 chains with said line to the beginning corner.
