State aforesaid, in the southwesterly part of the City of Greenville, on the
corner of Jenkins St. and Green Ave., having the following metes & bounds,
viz: beginning at a stake 34 rods from Jenkins St. James Miles corner running
thence with said St. 132 feet to a stake on Green Ave, thence N 20 E with Green
Ave, 184 feet to a stake 34, William Lynch's corner, thence with said Lynch's
line N 73 1/2 W 137 feet to a stake 34 along the back line, thence S 20 E with
Jas Miles line 183 ft. to the beginning corner.

The same being sold formerly as the property of Cox & Murphy, and adjoins
lands formerly belonging to Jas Miles and Wm Lynch. Same is also known
