release unto the said Martha M. Grayham, all that five parcel tract of land situate in the County and State aforesaid in Dunklin Township and on Little Horse Creek, bounded by lands belonging to R. B. Arnold, R. M. McGee, and Winrod Grayham; Beginning on a stone 117 on Winrod Grayham land, thence S 46 3/4 W 22.54 to a stake on Little Horse Creek; thence S 45 1/4 E 16.50 to a stake, thence S 35 E 3.14 to a stone 117; thence N 5 1/4 E 24.55 to a stake, thence N 48 1/2 E 22.00 to the beginning 117 containing forty nine 1/100 Acres, more or less, bounded by both tracts, will more fully explain by reference to plat herewith annexed, made by D. H. Boyce dated December the 28, 1870, and be it further understood that the five parcel of land, records, back to my mother Martha M.
