TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any-wise incident or appertaining.


TO HAVE AND TO HOLD all and singular the said premises before mentioned unto the said *J. B. Robinson* his Heirs and Assigns forever.
