 release unto the said W. D. Neobit his heirs and assigns

All of that certain piece, parcel and tract of land containing one hundred and six (106) acres, more or less, situate, and being in Oak Grove Township in Greenville County and in the State of South Carolina, lying on the west side of Reedy River, Beginning on a White Oak 3x0.m. on said river, thence S 77 W 8.60 to a Rock 8x2.m. in the road, thence South to South East S 2.17 along said road to the corner of road in center of Branch, thence up the meanders of said Branch N 45.05 E a stone x 3 m. thence S 54.81 E 9.00 to a stone x 3 m. thence S 37.56 E 16.00 to a stone at a Hickory stump x 3 m. (originally a Hickory corner) thence N 53.76 E 28.60 to a sage armore x 3 m. m on the aforesaid river. thence up the meanders of the river to the beginning corner - the same being in part of a tract of land surveyed to me by Lee on the 6th day of March A.D. 1888 by William A.
