Westmoreland June 21, 1880 and was deeded by the said T. P. Westmoreland to us the 3<sup>rd</sup> day of Feb, 1885 Beginning at the South West corner of the Locustini lot thence 8 65' E 3.88 chains to Stake thence 8 29 $\frac{1}{2}$  W 3.88 chains to an iron pin in the old Burncomb road, thence along said road thence 8 66 $\frac{1}{2}$  E 8.50 chns to an angle in road, thence 8 70 E 12.38 chns to W. L. Westmoreland corner thence with W. L. Westmoreland line N 27 $\frac{1}{2}$  E 31.00 chns to a stone on T. P. & Geo.
