release unto the said Annie L Owen all that certain piece of land in the City of Greenville County of Greenville State aforesaid being on the east side of Academy Street containing 59.54 sq. ft. more or less, having the following lines and bounds to wit; Beginning at stake on Academy Street at the corner of the lot of Mrs Mary Evans, thence S 69 1/2 E One hundred and ten (110) ft. to stake on the line of lot of John Gilreath, thence along his line N 23 E fifty four and one half (34 1/2) ft. to lot belonging to myself, thence N 69 1/2 W One hundred and eight and one half (108 1/2) ft. to stake on Academy Street, thence with such street S 64 W Fifty four and one half (34 1/2) ft. to beginning corner, Being in accordance with survey and plat of W A Hulston, hereto attached and being a part of and in rear of my home place on Bumcombe Street.
