of Decency, in consideration of the sum
and before the sealing of these presents by Greenville County
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and
release unto the said Greenville County

a strip of Land in the County and State of acceding and in the
Township beginning the old State Road near and below
what is generally known as the "Big Cave" on said State Road
and extending North of said State Road through my land
for a distance of about 200 yards to land of John Gozelle, said
piece or strip of land being 20 feet in width through the entire
width of my land and as to be used by the said County of
Greenville for a right of way for a public Highway said part
of the highway being a balance made in the said State Road
from said "Big Cave" to Mr. George Gilchrist's residence on
said State Road. Said piece or strip of land being a part
of the tract of land containing 45 1/2 acres of the estate of
Abraham Collins, and deeded to me on 18th January 1893.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Greenville County
etc., its successors and assigns
Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever
defend all and singular the said premises unto the said Greenville County etc., its successors
and assigns, and every person whomsoever lawfully
Holds and Assigos, against and every
claiming or to claim the same or any part thereof.
