(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and
release unto the said Greenville County

All that certain piece, parcel
or strip of land in the County and State of aforesaid and in
mead Township, lying on the old State Road near and below
what is generally known as the "Big Cove" on said State Road
and running North of said State Road through my land
for a distance of about 200 yards to land of John Goughall. Said
piece or strip of land being 20 feet in width through the entire
width of my land, and to be used by the said County of
Greenville as a right of way for a Public Highway - said right
of way being a change made in the said State Road
from said "Big Cove" to Mr. Emily Gilchrist's residence on
said State Road. Said piece or strip of land being a part
of the tract of land containing 42 1/2 acres of the State of
Abraham Collins, and deeded to me on 18th January 1895

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any
wise incident or appertaining.
TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Greenville Coun
ty, its successors and assigns Heirs and Assigns forever.

And I do hereby bind myself Heirs, Executors and Administrators to warrant and forever
defend all and singular the said premises unto the said Greenville County, its successors
and assigns Heirs and Assigns, against me and any Heirs, and every person whomsoever lawfully
claiming or to claim the same or any part thereof.
