Beginning at a stake 34, on Perry Avenue and running thence
W 18° 48' two hundred (200) feet, to a stake 34, on the Wace line, Thence
N 19° 48' W (63) sixty five feet to a stake 34, on the Wace line, Thence N 71° 48' fifty seven (57) feet to an iron pin 34, Thence S 18° 48' W two hundred
and fifty four (254) feet to a cherry tree 34, on Perry Avenue, Thence
along Perry Avenue S 71° 48' Ninety seven (97) feet to the beginning,
corner, containing one half of an acre more or less, adjoining
land belonging to the estate of Henry O'Leidner deceased and
