Whereas Sarah Burns Administratrix of the Estate of Sanders Burns, deceased, on or about the 27th day of February in the year one thousand eight hundred and ninety six did exhibit her Complaint in the Court of Probate in the County of Greenville and State aforesaid for the sale of the real estate of Sanders Burns in aid of personal assets to pay debt of the deceased.

And the cause being at issue before the Honorable the Court aforesaid came on to be heard on the 28th day of January one thousand eight hundred and ninety seven when the said Court, after a full hearing thereof and mature deliberation in the premises, did Order, Adjudge and decree that the real estate hereinafter mentioned and described should be sold at public auction by the Judge of Probate for Greenville County on the terms and for the purposes mentioned in the said Decretal Order, as by reference thereto on file in the said Court, will appear. Together with all and singular the rights members hereditaments and appurtenances whatsoever to the said premises belonging or in anywise appertaining and the reversion and remainders rents, issues and profits thereof, and also all the estate right, title, interest, dower, possession property, benefit, claim and demand whatsoever both at law and in equity of the said Sarah Burns Administratrix etc, and of all the parties to the said suit, and of all other persons, right fully claiming or to claim the same or any part thereof, by, from or under them, or either of them.

To have and to hold the said premises with its hereditaments, privileges and appurtenances unto the said Sarah Burns, her heirs and assigns forever.
