County of Greenville { Whereas J C Gower of the
County and State aforesaid departed this life leaving
of force his last will and testament, duly probated
and recorded, in the office of the Probate Judge for
said County, whereby after making certain specific
legacies, he devised and bequeathed one third of
his entire estate to his wife Sallie M Gower, and
the other two-thirds to his children to be equally
divided between them, and whereby he directed
further that in making the division my executors
and executors may sell the whole or any part
of my estate for the purpose, or may assign
any portion of the whole thereof to those entitled
thereto, if they can agree upon a fair division.

And whereas the said J C Gower left surviving
him his wife Sallie M Gower and his children
to wit: M G Grosweil, S E Mills, Arthur Gower,
Charles E Gower, Lola G Carpenter, Maire G Gourges
and J C Gower, and whereas the same was
under the power of probate, he has now and

a very considerable number of lots in tact, and
whereas the said widow and children of the said J C Gower
did on May 1st 1899 execute a written agreement whereby
among other things it was agreed that in dividing said
lands the executors, should assign and convey to Sallie
M Gower, the widow, and Maire G Gourges and J C Gower
the lands herein after described, at the price of three thousand
six hundred and fifteen Dollars.

Now, therefore, know all men by these presents, That in
consideration of the premises, and under the power
contained in the said will, and for the purpose of making
a division of the said lands in pursuance to the
terms of the said will, we, Arthur G Gower and Frank
Hammond as executors, and Sallie M Gower as
executrix, of the last will and testament of J C Gower
deceased, in consideration of the sum of Three Thou-
sand Six hundred and fifteen Dollars to us in hand
paid, at and before the sealing and delivery of these
presents (the receipt whereof is hereby acknowledged)
have granted, bargained, sold and released and
assigned, and by these presents do grant, bargain
sell and release and assign unto the said Sallie
M Gower, Maire G Gourges and J C Gower the following
lots or tracts of land situate in City and County
of Greenville, State of South Carolina, as follows, to wit:-

to wit: Beginning at a stake on Birnie Street, and running

line of Rebecca Proctors land, thence N 29 1/2 W 214 1/2 ft.
to a stake, thence S 62 1/2 W 65 ft. to a stake, thence S 29 1/2 W
214 1/2 ft. to the beginning corner, containing 536 1/2
