and before the sealing of these presents by  
and the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and  
release unto the said J. T. Rynd, all that lot or parcel of land  
located, situated, lying and being in the City of Greenville  
County of Greenville and State of South Carolina  
and bounded by lot No. 4 on the N.E. corner of the same  
line bounded by nothing on the West side hundred  
and ninety and one half (11 1/2) feet, and run-  
ning back from said front street five hundred  
and eighty seven (587) feet on the west line  
and four hundred and eighty-one (481) feet on  
the east line, being the same lot of land, covenanted  
by Rev. Mr. Burdine with said Ezra Newberry,  
which life interest passed unto said John Bur-  
dine and his wife Charlotte Burdine, and also  
a life interest reserved unto said Ezra New-  
berry, died bearing date October 14th 1876, and recorded in  
R. M. C. Book for said Greenville County S.C. on December
