Smith of the County of Greenville in the State aforesaid (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Hettie E. Smith all of that certain piece of land situated in White Springs, now called Franklinton, in the State aforesaid, beginning at a stone corner and field marking the same N 88° 14' E, to a red oak 8 ft. from the corner, thence N 44° 34' W, 60 ft. to a rock 40 ft. from a small spring branch, thence N 66° 36' E, 60 ft. to a rock 40 ft. to a rock 40 ft. thence S 24° 11' W, 37 ft. to a Post Oak 340 m. down, 2 rocks 40 ft. thence N 87° 11' W to a stone 34 ft. on Mary Hawkins line, thence N 42° 16' E, 23 ft. to a Mulberry tree, thence S 68° 11' W, 12 ft. to a rock 34 ft. thence N 44° 34' E, 63 ft. to a rock 34 ft. N.W. thence N 24° 11' W, 57 yards to the beginning of river, containing fifty acres more or less, bounded by C. G. King, W. B. Morgan, the White Plains place and others.
