the County of Greenville, S. C. on the North side of a twenty
foot street (said street running right angles with Bear Street)
and parallel with Choice Street) and commencing on Bear
St. 420 feet from Choice Street Beginning at a Stake upon said
20 foot street hence N. 72° E. One hundred (100) feet to a stake, thence
N. 89 1/2 W. fifty (50) feet to a stake, thence N. 1/2 W. one hundred
feet (100) to a stake. Thence with said street S. 89 1/2 E. fifty
