Earle, (the receipt whereof is duly acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Louisa E. Earle, her heirs and assigns forever, all that piece, parcel or lot of land situated on the east side of South Leach Street in the City of Greenville, known as lot No. forty-one (41) of the subdivision of the lands of the Mountain City Land and Improvement Company bought from Bacot & Browning. Said lot having the following metes and bounds: Beginning at a stake one hundred and thirty three (133) feet from the north east corner of Dunbar and Leach Streets, said point being the south west corner of the lot conveyed by this deed; thence with Leach Street N.eighteen (18) E.forty-three (43) feet to a point (the same being the south west corner of lot No.40); thence with line of No.40 E.seventy-six (76) E. two hundred (200) feet to a ten foot alley, thence along said alley S.eighteen (18) W.forty-three (43) feet to the north east corner of lot No.42; thence with the last mentioned lot No.seventy-six (76) W.two hundred (200) feet to the beginning corner on Leach Street. Being the same lot of land conveyed by the Mountain City Land and Improvement Company to The Workingman's Savings and Loan Company by deed bearing date February 14th.
