Bailey, all that certain lot of land situate in the County and State aforesaid, within the corporate limits of the City of Greenville in Ward 5, designated as Lot #6 on a plat of the lands of J. C. Ware, deceased, made by J. W. Southern surveyor, and having the following lines, to wit: - Beginning at corner of Ware Street and Perry Avenue (formerly Douthat Street), thence with Ware Street 2 chains and 69 links to corner of lot No. 7, thence with lot No. 7, 2 c. 88 l. to Lot now an formerly belonging to H. S. Leidner, thence with that lot to Perry Avenue, thence with Perry Avenue two hundred and forty-five feet to beginning. Being the lot conveyed to me by J. C. Burgess, of Green State and County above mentioned, in the State aforesaid for and in consideration of the sum of Three hundred and fifty (\$350.00) Dollars to me in hand paid at and before the sealing of these presents by Franklin Mills (the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Franklin Mills, all that certain slip or right of way of land leading through the property I bought of Mrs. C. C. Ballinger, but deeded me by J. D. Norman, Master, Spartanburg County, also the slip or right of way through the lot on Broad Street deeded me by J. W. Mayfield, said slip being twenty feet wide and running all the way through both lots above referred to and is the ground graded by Southern Ry. Co. for a side track leading to Franklin Mills from the main line of said Railway Company and is to be used only for a side track. If the said land should not be used for right of way or side track for the purpose of reaching Franklin Mills and if unused for the term of three years in other words when the said land ceases to be used as a right of way to reach said Mill, then it reverts to W.
