 release unto the said Sarah Verona Neal,

All that certain piece, parcel and tract of land situate, lying and being in Greenville Township; in Greenville County in the State aforesaid, containing seven and seven tenths acres, more or less, and being nearly two miles from Greenville Court House on the Anderson Road, between said road and the Columbia & Greenville Railroad, beginning on a stake on the Anderson Road and running thence S. 45° E. 8.89 to a rock x O. on said railroad, thence along said railroad S. 62 W. 3.94 to a corner marked "angle" in a plat made by H. P. Johnson March 12th. 1881, thence along said railroad S. 69 W. 5.85 to a corner marked "angle" in said plat, thence S. 74 W. 3.16 to a stake x N. along said railroad, thence N. 19 1/2 W. 5.69 to a stake x N. on the Anderson Road; thence N. 56 1/2 E. 5.40 to a P. O. x N. on said road and along said road, thence N. 49 E. 4.16 along said road to the beginning corner, being the same tract of land conveyed to Sophia W. Jenkins by Kittie B.
