STATE OF SOUTH CAROLINA. Whereas James Lenderman did by deed bearing date the 9th day of February County of Greenville, A.D. 1871 and recorded in the office of the Register of Deeds Conveyances for said County in Book C.C. page 483 convey to W.M. Lenderman and others a certain lot of land described in said deed on certain trusts in said deed set forth; and whereas a certain church known as Reedy Fork Baptist Church has grown out of the religious exercises authorized by said deed in the School house on said lot and it is to the best interest of said Church that it should have a separate building for its public worship, now therefore KNOW ALL MEN BY THESE PRESENTS.

That we, W.M. Lenderman, Henry Harris, James Cox, W.A. Pepper and P.D. Huff a majority of the Trustees named in said deed and being all of said Trustees now living

in the State aforesaid in consideration of said promises and in consideration of the sum of Five Dollars to us in hand paid at and before the sealing of these presents, by John M. Riddle, W.T. Riddle and W.H. Ashmore, Deacons of said Baptist Church (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John M. Riddle, W.T. Riddle and W.H. Ashmore, Deacons of said Baptist Church and their successors in the office of Deacon of said Baptist Church and heirs and assigns forever all that piece, parcel and lot of land situate, lying and being in the County of Greenville and State aforesaid, being a part of said lot of land conveyed in Trust as aforesaid, and containing one and one-half acres more or less and having the following metes and bounds and courses and distances to wit: Beginning at a stone on the southern line of the said lot of land conveyed by said trust deed as above stated, nearly midway on said line, and running thence N. 1 1/2 W. 5.89 to a pine, thence S. 41 3/4 W. 7.88 to a stone at a corner, thence S. 88 E. 5.23 to the stone at the beginning.

TOGETHER WITH ALL AND SINGULAR THE RIGHTS, MEMBERS, HEREDITAMENTS AND APPURTENANCES TO THE SAID PREMISES BELONGING, OR IN ANYWISE INCIDENT OR APPERTAINING. TO HAVE AND TO HOLD, ALL AND SINGULAR THE SAID PROMISES BEFORE MENTIONED, UNTO THE SAID JOHN M. RIDDLE, W.T. RIDDLE AND W.H. ASHMORE, DEACONS OF THE SAID REEDY FORK BAPTIST CHURCH THEIR SUCCESSORS IN OFFICE AND HEIRS AND ASSIGNS FOREVER.

The said lot of land shall always be held on the following trusts and confidence and in such persons as are or shall be the Deacons of said Church and the said lot of land shall be forever held by them in trust to allow and permit house for religious worship to be maintained or built and maintained thereon for the use and purposes of the said Reedy Fork Baptist Church forever in which to conduct religious exercises and worship according to the faith and practice of the missionary Baptist Denomination; and said ground shall also be held for the accommodation of persons assembled there to attend preaching and other religious services in said house including the right to hitch their stock and leave their vehicles thereon while attending such service and what portion thereof shall not be made for such purposes and for said house shall be held by said Deacons and set apart by them as a grave yard or burial ground for persons of the white race in which all such persons so desiring shall be permitted to bury their dead under the supervision of such Deacons of said Reedy Fork Baptist Church.

And we do hereby bind ourselves our heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said John M. Riddle, W.T. Riddle and W.H. Ashmore, Deacons of said church and their successors in office, and our heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
