 State of South Carolina, Lease. Mitchel & Martha Carr to  
 County of Greenville. W.P. Chiles.  
 This indenture made the 22 day of June 1905 by and between Mitchel Carr & Martha Carr of the County of Greenville and State of South Carolina, party of the first part and W.P. Chiles of the County of Greenville and State of South Carolina, party of the second part, witnesseth:-  
 I-That in consideration of the sum of one dollar paid by the party of the second part to the party of the first part, the receipt whereof is hereby acknowledged, and the further consideration of the sum of \$20.00 dollars per ton royalty paid by the said party of the second part to the party of the first part for Monazite mined and to be mined on the premises herein below described and taken therefrom and the party of the first part does hereby give, grant, lease and confirm unto the party of the second part his heirs, executors, administrators and assigns for a term of 10 years beginning with the date of this instrument full and exclusive right to enter upon the premises and to remove therefrom the hereinafter described premises, and to mine, dig, and carry away all Monazite that may be found thereon, with the full liberty of ingress and egress and to use the same in his, the said party of the second part, his heirs, executors, administrators and assigns and his and their servants, agents and workmen in carrying out the purpose of this lease, for the purpose of searching for, working, getting and removing Monazite located thereon, and therein and generally to do all things necessary and proper for working and getting the same Monazite, and to use the same in his, the said party of the second part, his heirs, executors, administrators and assigns and his and their servants, agents and workmen in carrying out the purpose of this lease.

All that tract of land on which the Mitchel Carr now lives and known as the old Michum place situated on branch of Brushy Creek south west of Brushy Creek joining lands of Mr Rosa K Ashmore Mrs W.W. McGee and others.  
 II. And it is further agreed by the party of the first part, that if the Monazite upon the said premises shall not be exhausted at the expiration of this lease then the said party of the second part, his heirs, executors, administrators and assigns, shall have the option and refusal of extending this lease for a period of ..... years after the expiration of this lease and that the party of the second part shall elect and exercise said option, and shall pay to the party of the first part the royalty above mentioned, upon all Monazite concentrates thereafter mined and taken therefrom, and notice by the party of the second part given thirty days before the expiration of this lease, of the purpose to continue and extend the lease as aforesaid shall have the effect of continuing and extending the same for the additional period or term named.  
 III. The parties of the second part agree to pay for all damage that may be done by them or their workmen to any cultivated crops on said premises.  
 IV. It is further agreed that at any time within the period first named, that if the said parties of the second part shall desire to purchase the said property or the mineral interest therein he or they shall have the right to do so by the payment by him or them to the party of the first part the sum of ..... dollars, for the property, or the sum of ... dollars for mineral interest therein, and we, the party of the second part, agree to execute in consideration of such payment a warranty deed in fee of said premises aforesaid, or the mineral interests therein, as the case may be, to the parties of the second part, where upon payment of royalties hereinbefore mentioned shall cease.

And the parties to this contract do bind themselves, their heirs, executors, administrators, successors and assigns, to the carrying out and the execution of the said contract according to the terms, conditions and stipulations thereof.
