482 State of South Carolina, Lease J.T. Campbell and wife to County of Greenville. T.M. Alexander.

This Indenture made the 9th day of May 1905 by and between J.T. Campbell and wife of the County of Greenville and the State of South Carolina party of the first part and T.M. Alexander of the County of Greenville and State of South Carolina party of the second part witnesseth; -

I. That in consideration of the sum of one dollar paid by the party of the second part to the party of the first part, the receipt whereof is hereby acknowledged, and the further consideration of the sum of Twenty (20) dollars per ton royalty paid and to be paid by the party of the second part to the party of the first part for Monazite mined and to be mined on the premises hereinbelow described and taken therefrom, the said party of the first part does hereby give, grant, lease and confirm to the party of the second part, his heirs, executors, administrators and assigns full and exclusive right to enter upon in person and by agents and servants the hereinafter described premises, and to mine, dig, take and carry away all Monazite that may be found thereon with full liberty of ingress, egress and redress at all times to him, the said party of the second part, his heirs, executors, administrators and assigns and his and their servants, agents and workmen, in and upon the hereinafter described premises, for the purpose of searching for, working, getting and carrying away all Monazite located thereon and therein, and generally to do all other things necessary and proper for the working and getting the said Monazite, that is to say upon the land and premises described as follows;

All the branch beds on J.T. Campbell's place joining lands of J.C. Allen and others known as Campbell's place with the right to make roads and ditchies.

The parties of the second part agree to pay for all damage that may be done by them or their workmen to any cultivated crops on the said premises.

And the parties to this contract do bind themselves, their heirs, executors, administrators and assigns to care for and protection of the said land and the rights of the owners, tenants and lessees thereof.

483 State of South Carolina, Lease J.D. & I.D. Vaughn to County of Greenville. T.M. Alexander.

This Indenture made the 6th day of May 1905, by and between J.D. Vaughn & I.D. Vaughn of the County of Greenville and State of South Carolina party of the first part and T.M. Alexander of the County of Greenville and State of South Carolina, party of the second, witnesseth; -

I. That in consideration of the sum of one dollar paid by the party of the second part to the party of the first part, the receipt whereof is hereby acknowledged, and the further consideration of Twenty (20) dollars per ton royalty paid and to be paid by the said party of the second part to the party of the first part for Monazite mined and to be mined on the premises hereinbelow described and taken therefrom, the said party of the first part does hereby give, grant, lease and confirm unto the party of the second part, his heirs, executors, administrators and assigns, for a term of one year, beginning with the date of this instrument, full and exclusive right to enter upon in person and by agents and servants, the hereinafter described premises, and to mine, dig, take and carry away all Monazite that may be found thereon with the full liberty of ingress, egress and redress at all times to him, the said party of the second part, his heirs, executors, administrators and assigns and his and their servants, agents and workmen, in and upon the hereinafter described premises for the purpose of searching for, working, getting and carrying away all Monazite located thereon and therein, and generally to do all other acts and things necessary and proper for the working and getting the said Monazite, that is to say upon the land and premises described as follows; -

All the beds of the branch and bottom on J.D. Vaughn's place on the waters of Ready River, about one mile from Mr. Schiff and others one mile east of Santandam Po.

It is further agreed by the party of the first part, that if the Monazite upon said premises is greater than the quantity of this lease, then the said party of the second part
