And I do hereby bind myself and my executors and administrators to warrant and forever defend all and singular, the said premises unto the said D. S. Pack, his heirs, executors and administrators.

Heirs and Assigns, against D. S. Pack and Mary L. Pack, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
