McCallough, his Heirs and Assigns*, against *Every person, whomsoever lawfully claiming the same* and *claiming the same* Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof, *has hereunto caused its corporate seal to be attached and has caused Frank Hammond, President and Alex. & Furman its treasure to subscribe hereunto in the corporate name this 1st day July 1903 in the year of our Lord one thousand, nine hundred and third* and in the one hundred and 29<sup>th</sup> year of the Sovereignty and Independence of the United States of America.
