TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appurtaining. TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said White OAk Camp No 272 Woodmen of the World, its successors and assigns, subject however to the conditions and limitations herein-above set forth, that is to say if the said White Oak Camp No 272, Woodmen of the World fails to erect said building on said lot, or ceases to use the hall as its meeting place for a period of one year, then the title to said premise with the improvements thereon, is to immediately revert to me, the said Mrs S.L.
