on the said Plat which is ----- feet from all streets. Fifth, That no use shall be made of the lot sold, or any part thereof, which woold constitute a muisance or injure the value of any of the neighboring lots.

Sixth: That the lay out of the lots as shown on said plan shall be adhered to, and no scheme of facing lots in any other direction than that shown on said Plat shall be

Seventh: That the Company reserves the right to lay and place or authorize the laying and placing of electrin of other street car tracks, sewer, gas and water pipes, electric conditate conduits or pipes, tolegraph, telephone and electric light poles, or any other work or instrument of public utility, on or in any of the Streets of said Riverside, which out compensation to any lot owner.
