Peoples, late of the City and County of Anderson in the State aforesaid, in consideration of the sum of One Dollar to us in hand paid at and before the sealing of these presents by Lillian C. Smith (nee Howell) of Greenville County in said State (the receipt whereof is hereby acknowledged) have of Greenville County in said State (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lillian C. Smith, all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina and County of Greenville, in O'neall Township on waters of Beaverdam Creek of Encree River, on the read known as the McElhany Ford Road, running from Jackson Grove Church to Travellers Rest, containing Seventy—eight (78) acres, more or less and known as tract numbered Two (2) of Mrs. Elsie F. Howell's land, according to a Plat thereof made by B.F. Neves on the 16th, day of September, 1907 and having according to such survey the following metes and bounds to wit: Beginning at a stone on the South side of the McElhany Ford Road on corner of a tract of Land this day conveyed by us to John P. Howell and running; thence along his line S. 23 W. 32.50 chains to a rock on Beaverdam Creek; thence down said Creek as the line following the meanders thereof to a stone and stake in Beaverdam Creek on Gilreath's corner; thence N. 30 W. 15.25 ch. to a stone; thence N. 6 W. 18.00 ch. to a stone and Pine; thence N. 54 W. 1.05 ch. to a stone; thence N. 5 W. 20.78 oh to the stone on the South side of the McElhany Road; thence along said road in a Westerly direction 7.90 ch. to the beginning stone corner, adjoining lands of John P. Howell, (being tract No .1, of Mrs. Elste F. Howell Estate) Mary J.-Howell, (being tract No. 3 of said Estate) A.N. Gilreath and Gilreath Brothers and being a portion of a tract of land conveyed as 252 acres by Mrs Emily C. Gilreath to Josephine S.

Peoples, Sylvester Bleckley (since deceased) and Joseph J. Fretwell, Trustees by & deed bearing date Jamuary 1, 1890, and recorded in the office of the Register of Mesne Conveyences for Greenville County, South Carolina on January 21, 1891 in Book "WW" of Deeds at page 475 in trust to hold the land therein conveyed for the use and benefit of Mrs. Elsie F. Howell during the term of her natural life, and after her death to divide the said tract of land equally among her children; the said Elsie F. Howell having departed this life leaving surviving her three children, namely John P. Howell, Lillian-C. Howell (now Smith) and Mary J. Howell; the said tract of land having been resurveyed by B.F.
