Reid, of the County of Greenville, in the State of South Carolina, the receipt where of is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, seal and release unto the said N.H. Reid All That certain lot or parcel of land situate, lying and being in the County of Greenville and State of South Carolina, in what is known as Park-Place, near the City of Greenville, a revised plat of which is of record in the Register of Mesne Conveyance office for the County of Greenville in the State of South Carolina in plat book A at page 119, said lot being number 8 on said revised Plat in block 4 and a part of the tract of land which was sold and conveyed to J.W. Cagle, T. Q. Donaldson and William Wilkins by Alexander Stewart and Jacob H.
