Together with all and singular the rights, members, hereditaments and appurtenances to the said interest belonging or in anywise incident or appertaining for said S.V. Chandler and K.S. Chandler.

To have and to hold all and singular the interest before mentioned unto the aforesaid Chandlers, their heirs and assigns forever.

And we do hereby bind ourselves, our heirs executors and administrators to warrant and forever defend all and singular the said interest unto the aforesaid Chandlers, their interest to their heirs and assigns against ourselves and our heirs lawfully claiming or to claim the same or any part thereof.
