KNOW ALL MEN BY THESE PRESENTS, That We, George A. Norwood, J.W. Norwood, Sarah N. Key, Lula N. Mullins, Clara N. Watson, Samuel W. Norwood, Joseph Norwood and Annie N. Moss for and in consideration of the sum of Thirty-five hundred dollars to us in hand paid at and before the sealing and delivery of these presents by A.H. Shaver (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A.H. Shaver, his heirs and assigns, all that lot or parcel of land situate on the West side of Ware Street, in the City and County of Greenville, South Carolina, being a part of Lot No. 9 of the T.E. Ware Lands as shown by plat recorded in Plat Book A. page 270, fronting on said Ware Street one hundred and twenty four feet and running back in parallel lines two hundred feet, bounded by lands of said Shaver on the South and by Holleman on the North said lot being the portion of lot No. 9 nearest Perry Avenue, and being part of the lot conveyed to G.A. Norwood by W.W. Price, the 6th, day of January 1891 and recorded in Book X.X., at page 584, and devised by him to us.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
