This Indenture made this 17, day of December, in the year of our Lord one thousand nine hundred and sex, between Am Ann Gorden of the County of Henderson and State of North Carolina of the first part, and J.M. Bell of the County of Greenville, and State of South Carolina of the Second part, WITNESSETH:

WITN ESSETH:

That the said parties of the first part, for and in consideration of the sum of Thirty Dollars, in hand paid by the said Party of the second part, the receipt whereof is hereby acknowledged have bargained and sold, conveyed and confirmed, and by these presents do bargain, sell, convey and confirm unto the party of the second part his heirs and assigns forever, all the following described piece or parcel of Land Lying and being in the Township of Green River, County of Henderson, and State of North Carolina and known and designated as follows, Viz:

joining the lands of L.E. Ward on the North Carolina side and R.W.J. Pace and others on the South Carolina side. This being an undivided interest in all the lands owned by Mark Russell, deceased this being one or more tract of land part in South Carolina and a fart in North Carolina, what is intended to be conveyed here is my entire undivided interest, that I have or may have in all the lands owned by my Father Mark Russell, deceased in the foregoing mentioned Counties and States.

To have and to hold the same, Together with all the hereditaments and appurtenances there unto in anywise appertaining. And the said Ann Gorden parties of the first part, do covenant with the said party of the second part, her heirs and assign, as follows:

First, that they are the owners and lawfully seized of said premises,

Second, that she has a good right to convey the same.

Third, that the same are free from all encumbrances whatever, And Fourth that they party of the second part his heirs and assigns shall quietly enjoy and possess the same, and that she will warrant and defend the title to the same against all lawful claims.
