KNOW ALL MEN BY THESE PRESENTS, That I, Will S. Turner of the City of Greenville, County of Greenville, State of South Carolina, party of the first part, in consideration of the sum of One dollar, and other valuable considerations, to me paid by George E. Miller, of Stoneham, in the County of Middlesex, State of Massachusetts, party of the second part, (the receipt whereof I do hereby acknowledge) have bargained, granted, sold set over, assigned and conveyed, and by these presents do bargain, grant, sell, set over assign and convey unto the party of the second part, his executors, administrators and assigns, all my right, title, and interest in a certain patent obtained by me from the United-States Government, the same known as the Will S. Turner Graining Tool, Number-567523, patent granted September 8th., 1896; hereby conveying every right to the said patent to manufacture, sell and transfer the same, the same as I might do my-self, and granting all power, rights and interest now vested in me unto the said George E. Miller, party of the second part, except such rights as I heretofore granted to the Carolina Buggy Company, of Yorkville, South-Carolina; said right being for their use exclusively, in the County of York, South Carolina, and such rights as I have granted George Hodges, Esq., for the sale of said Graining Tool in the Cities of Newberry, Greenwood and Laurens, and such rights as I have granted to the colored school in Orangeburg, South Carolina, for the use of said Tool only in said School; however, none of the above parties having been granted the right to Manufacture in any way ^{whether} the said Tool. And I do, for my-self, my heirs, executors, administrators and assigns, covenant and agree to and with the said party of the second part to warrant and defend the said party of the second part, the said described patent hereby sold unto the said party of the second part, his executors, administrators, and assigns against every person and persons, whosoever, granting to him in every way all rights which I may have to said patented article, and all rights to recovery for infringement of same prior to this day, or otherwise.
