The said Railway Company hereby licenses the said Town Council to Locate, open and ... maintain a Street upon the outer edge of its right of way (which at the point in question is one hundred (100) feet from the center of its Main line) thirty (30) feet wide parallel with said main line, extending from the second railroad crossing East to the Depot to the corporate limits of the Town, a distance of about six hundred (600) feet on the Southern side of the Railroad, upon the conditions hereafter named. The Said Town Council agrees that at any time hereafter upon thirty (30) days written notice by the Railway Company of its purpose to use the portion of its right of way hereinbefore refferred to, licensed as aforesaid of which purpose the Railway Company shall be the Sole Judge, it will close the said Street and that the license herein granted shall be revoked.
