stone in Branch; thence up said Branch to the
C. containing forty-four one hundredths
acres more or less, bounded by N. El. Garrett,
William Larks and others

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident
or appertaining. TO HAVE AND TO HOLD all and singular the said premises before mentioned, unto the said
