and being in the the State County aforesaid about 13, miles from the City of Greenville on the Augusta road; beginning at a stone X 3 on; thence running S. 77 1/4 E. 36.70 to a iron stake X 6; thence N. 14 1/2 E. 14.85 to iron stake X 3; thence running N. 77 1/4 W. 26.70 to pine-knot X 3 mm; thence S. 14 1/2 W. 14.85 to the beginning corner containing 54 1/2 acres, and adjoining lands of A.P. Norris, A.N. McDavid and others and known as part of the Nesbitt and Trowbridge Tract.
