Orr, lying between Furman Road and Langston Creek and hath the following notes and bounds, to-wit; beginning at an iron pin in Langston Creek, James Trammell's, & Kenneth's corner and runs S. 83-1/2 E. with said line 7.25 to Furman Road; thence N. 8-1/2 E. 1.01 to iron pin on said road; thence N. 82 W. 7.75 to iron pin in Langston Creek thence down said creek to the beginning, containing one acre, more or less bounded by Trammell's lot C. D. Drake and others.
