Know All Men By These Presents, That The Camperdown Mills a corporation created under and by the laws of the State of South Carolina in the State aforesaid, for and in consideration of the sum of Eight hundred and fifty Dollars, to it in hand paid at and before the sealing of these presents by The Charleston & Western Carolina Railway Company, a corporation existing under and by the laws of South Carolina, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charleston and Western Carolina Railway Company, its successors and assigns All that piece, parcel or strip of land situate, lying and being in the City of Greenville County of Greenville and State of South Carolina between Fall and Main Streets and running from Fall Street to Main Street, it being the right of way that the tract of the Charleston and Western Carolina Railway Company is now located on and being at the north end of the factory and office of the said Camperdown Mills, the said strip being thirteen feet in width and 367 feet in length from Fall Street to Main Street all of which will more fully appear by reference to a blue print showing the location of the same hereto attached and made a part of this deed,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said Charleston & Western Carolina Railway Company, its successors Heirs and Assigns forever

And it does do hereby bind itself, its successors and assigns, Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said Charleston and Western Carolina Railway Company, its successors and assigns

Heirs and Assigns, against this Company and its successors Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
