NOW, Therefore, Know all Men by these Presents, that I, J. W. GRAY, Master in and for the County of Greenville, aforesaid, in consideration of the performance of the conditions aforesaid, and the payment of Dollars by the said Louise Earle and India Earle

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said Louise Earle and India Earle all that certain lot or parcel of land no north side of Southern Railway and Pendleton road, and two and one half miles from Greenville S.C. containing

two acres more or less and bounded as follows:- Beginning at a stone on Pemdleton road, thence N 27-3/4 W. 4.15 to an iron pin; thence S. 70 W. 2.30 to iron pin, thence S. 72-2/3 W. 7.68 to stone on Pendleton road; thence with Pendleton road N. 87-1/4 E. 4.80 then due East 6.90 to stone at beginning

corner. Said tract being in Greenville County in South Carolina, and being the same tract of lot conveyed to Edward I. Earle by J. W. Gray Master May 28th 1906, deed recorded in R.M.C. office in and for Greenville County in Book KKK at page 192. Also, all that certain piece, parcel or lot of land situate, lying and being in County & State aforesaid, about two and one half miles from Greenville S.C. containing two and seven tenths acres more or less, and bounded as follows:- Beginning at a stake on Southern Railway crossing N. 6 E. 1.60 to an iron pin near well; thence S. 87-1/2 W. 7.60 to forked locust; thence N. 80 W. 8.08 to iron pin, thence S. 27-1/2 W. 3.78 to an iron pin at southern railway; thence along line of said railway N. 87-3/4 E. 16.65 to the beginning corner, said tract being the same conveyed to Edward I. 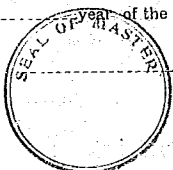
