demanding judgment in relation to the Real-estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 11th day of October 1909, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real-estate hereinafter mentioned and described, be sold by J. NOW, Therefore, Know all Men by these Presents, that I, J. W. GRAY, Master in and for the County of Greenville, aforesaid, in consideration of the sum of Five hundred and thirty Dollars, to me paid by the said

S.B. Huff the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said S.B. Huff, all that certain parcel or tract of land situate, lying and being in Dunklin Township, County and State aforesaid, known as tract No. 3 of the survey of the lands of J.W. Ridgeway, deceased, containing fifty-two and one-half (52-1/2) acres, more or less, and having the following metes and bounds as shown by Plat of survey made by James P. Willis, S. on the 16th, day of September, 1909 to wit: Beginning at stone on Horse Creek, corner of Lot No. 4 and running; thence N. 64-1/2 E. 34.10 to stone 3X on Public Road; thence N. 11-1/2 W. 10.80 to stone 3X at mail-box; thence N. 4 W. 5.70 to stone 3X in old road; thence S. 53-1/2 W. 8.72 to stone 3X; thence S. 71-1/4 W. 8.00 to point on branch; thence S. 77 W. 2.80 to point on branch; thence S. 64-1/2 W. 12.00 to stone 3X near Ash at junction of branch and Horse Creek; thence along Horse Creek as a line S. 8 E. 16.50 to the beginning.
