NOW, Therefore, Know all Men by these Presents, that I. J. W. GRAY, Master in and for the County of Greenville, aforesaid, in consideration of the sum of Four hundred and twenty-five Dollars, to me paid by the said D. Arthur Pearson

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said D. Arthur Pearson, all that certain piece, parcel or tract of land lying, being and situate in the County and State aforesaid, containing thirty-seven acres, more or less, known as tract No. 2 in the partition of the lands of F.W. Pearson, deceased, and having the following metes and bounds, to wit: Beginning at a stake in road and running; thence N. 76-1/2 E. 13.50 to stone; thence N. 10 W. 36 links to stake in Road; thence N. 4 E. 25.65 to stone; thence N. 60-1/2 W. 7.40 to stone on J.A. Woods line; thence S. 56 W. 4.90 to stone; thence S. 30-1/2 W. 16.00 to sycamore; thence S. 54 E. 6.18 to stone; thence S. 33 E. 6.55 to stone; thence S. 40-1/2 W. 3.00 to road; thence along said road to the beginning corner, as shown by plat of survey made by B.F. Neves on the 20th, day of August, 1909

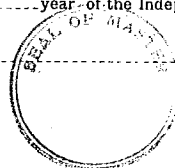
To HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said D. Arthur Pearson, his
