the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said F.B. Holland, all that certain lot or parcel of land situate in the City and County of Greenville, County and State aforesaid described as follows: Beginning at an iron pin on the East side of Augusta St. at corner of lot formerly owned by Mary J. Vaughan, and running; thence with Augusta St. S. 20-29 E. 117 feet to an iron pin, corner of Augusta and McKay Streets; thence with McKay Street N. 89 E. 177 feet to an iron pin, thence S. 81-40 W. 194 feet, six inches to the beginning corner.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever, of the parties to the cause aforesaid, and of each of them in and to the same; and of all other persons rightfully claiming from, under, or by these or any of them.
