to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Edith M. Hoke, of the County of

Greenville in the State aforesaid, all that certain piece, parcel and lot of land situated lying and being in the City and County of Greenville in the State aforesaid on the corner of Main and Oak Streets and having the following lines, metes and bounds, to wit:

Beginning in the line of Main Street and the corner of the said Edith M. Hokes, lot and running thence N. 74.30 E. 90 feet to an iron pin; thence N. 70.55 W. 90 feet, more or less to an iron pin in the line of Main Street; thence with Main Street N. 17 W. three feet and five inches (3.5) to the beginning corner.

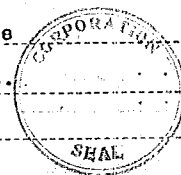

Hoke, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
