KNOW ALL MEN BY THESE PRESENTS, That The Mountain View Land Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Four Hundred Dollars

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto M.L. Gullick, of Greenville, S.C.

All that certain piece, parcel or lot of land situated in the County of Greenville State of South Carolina, having the following metes and bounds to wit: Commencing at a stake W. side of the Buncombe Road; thence 183 feet to a stake on a ten foot Alley; thence 45 feet with said Alley to a stake; thence 180 feet to a stake on the Buncombe Road thence with said Road S. 23-1/2° E. 60 feet to the beginning stake. Being Lot No. 9 Block A. as shown on the map of the Mountain View Land Company as surveyed by W.A. Adams, February 1910.

IT IS A PART OF THE CONSIDERATION:-

First: That the property is not to be sold, rented or otherwise disposed of to persons of African descent.

Second: That no liquor or Ardent spirits are to be sold on the property.

Third: That no use shall be made of the lots sold, or any part thereof which would constitute a nuisance or injure the value of any of the neighboring lots.

It is part of the consideration in event of a violation of the purchaser of the first provision above, the title to the lot shall revert to the grantor, except as against lien creditors and in event of a violation of any of the other provisions above, the grantor shall have the right to enforce the same by proper proceedings.

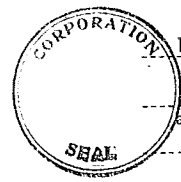
