Georgie A. Williams that certain lot of land situate in the City of Greenville, in the County and State aforesaid, fronting on Stall Street fifty feet with a depth of one hundred and twenty feet, having the following lines:

Beginning at a stake on Stall Street eighty feet from the Southeast corner of David and Stall Streets, thence with Stall Street S. 66 1/4 W. fifty feet to stake; thence parallel with David Street S. 23-3/4 E. 120 feet to a stake; thence along line parallel with Stall Street N. 66 1/4 E. fifty feet to a stake; thence along line parallel with David Street N. 23-3/4 W. 120 feet to the beginning. Being composed as follows: the front of part of lot conveyed by Mary J. Gambrell to Greenville Investment Company and the rear portion of part of lot conveyed by Mountain City Land and Improvement Company to Greenville Investment Company.
